ORDER.

The petition of L. A. Hunt, M. W. Knickerbocker and J. P. Duckett and fifty others, praying for the organization of the Squaw Creek Irrigation District under the provisions of Chapter 7, of Title 41, Lord's Oregon Laws as amended coming on now for hearing, and

It satisfactorily appearing to the Court that said petition was duly and regularly filed herein and was presented to this Court for hearing on the 2nd day of March, 1916 at the hour of ten o'clock in the forenoon of said day, and the Court, after considering said petition as presented by said petitioners thereupon adjourned and continued said hearing until Wednesday, the 15th day of March, 1916 at the hour of ten o'clock in the forenoon of said day, for the purpose of further hearing and considering said petition.

And now, at this time, being the date set for further considering said petition, and it appearing to this Court that said petition and notice of said hearing for the 2nd day of March 1916 as aforesaid has been duly published as required by law once each week for four successive weeks before the time at which said petition was to be heard by the Court in the Bend Bulletin, a weekly newspaper of general circulation published at Bend, in Crook County, Oregon, proof of which publication has been duly filed herein; and said petition and notice of said hearing was duly published as required by law once each week for four successive weeks before the time at which said petition was to be heard by this Court in the Deschutes Valley Tribune, a weekly newspaper of general Circulation published in Culver, Jefferson County, Oregon, proof of which publication has been duly filed herein; and the said petitioners, having

accompanied said petition with a good and sufficient bond as required by law in double the amount of the probably cost of organizing said District, which cost is estimated to be the sum of Five hundred (\$500) dollars, said bond being for the sum of One thousand dollars and which bond is hereby accepted and approved by this Court;

And it further appearing to this court that portions of said proposed district lie within Crook County, Oregon, and portions thereof lie within Jefferson County, Oregon and that a greater portion of said proposed District lie within Crook County, Oregon;

And it further appearing satisfactory to the court that the requisite number of owners of the title of lands within the said District have signed said petition presented to this Court for the organization of said Squaw Creek Irrigation District;

And it appearing to the Court that the boundaries of said proposed Squaw Creek Irrigation District intended and proposed by said petition are as follows: Beginning at the northwest corner of Section Five (5) in Township Fifteen (15) South, Range Ten (10) E. W. M., within Crook County, Oregon, running east to the intersection of Squaw Creek with the township line on the north side of said township fifteen (15) South Range Ten (10) East, thence in a northeasterly direction down Squaw Creek and following the meanderings of said stream along the center of said stream to the boundary line between Jefferson and Crook Counties; thence following on down said stream within Jefferson County to its junction with the Deschutes River; thence in a southeasterly direction up the Deschutes River and following the meanderings of said river within Jefferson County to the line between Jefferson and Crook Counties; and thence following on up said Deschutes River to the intersection of said stream with the section line on the south side of Section Fourteen (14) Township Fourteen (14) South Range Twelve (12) East W. M. in Crook County, Oregon. Thence westerly to the southwest corner of said section fourteen (14); thence southerly to the quarter corner on the east side of Section Twenty two (22) Township Fourteen (14) South Range Twelve (12) E. W. M. in Crook County, Oregon, thence westerly to the southeast corner

of the southeast quarter of the northeast quarter ( $SE\frac{1}{4}NE\frac{1}{4}$ ) of said Section;  
thence southerly to the southwest corner of the southeast quarter of the  
southeast quarter ( $SE\frac{1}{4}SE\frac{1}{4}$ ) of said Section Twenty-two (22); thence westerly  
to the quarter corner on the south side of Section Twenty two (22);  
thence southerly to the southwest corner of the northwest quarter of the  
northeast quarter ( $NW\frac{1}{4}NE\frac{1}{4}$ ) of Section Twenty seven (27) of said township  
and range; thence westerly to the southwest corner of the northeast quarter  
of the northwest quarter ( $NE\frac{1}{4}NW\frac{1}{4}$ ) of said section; thence southerly to the  
southeast corner of the southeast quarter of the northwest quarter ( $SE\frac{1}{4}$   
 $NW\frac{1}{4}$ ) of said Section twenty-seven (27) thence westerly to the quarter  
corner on the west side of said Section twenty-seven; thence southerly  
to the southwest corner of the northwest quarter of the southwest quarter  
( $NW\frac{1}{4}SW\frac{1}{4}$ ) of said section; thence westerly to the southwest corner of the  
northeast quarter of the southeast quarter ( $NE\frac{1}{4}SE\frac{1}{4}$ ) of Section Twenty-  
eight (28) Township Fourteen (14) South Range Twelve (12) E. W. M; thence  
southerly to the southwest corner of the southeast quarter of the south-  
east quarter of said Section twenty-eight (28) thence westerly to the south-  
west corner of Section Twenty eight (28) thence southerly to the south-  
west corner of Section four (4) Township Fifteen (15) South Range Twelve  
(12) East W. M; thence westerly to the southwest corner of Section Three  
(3) township fifteen (15) South Range Eleven (11) East; thence Southerly  
to the southwest corner of Section Thirty-four (34) of said township and  
range; thence westerly to the northeast corner of Section Five (5)  
Township Sixteen (16) South Range Eleven (11) E. W. M.; thence southerly  
to the southeast corner of Section Seventeen said township and range; thence  
westerly to the township line on the west side of said township; thence  
northerly to the southeast corner of Section Twelve (12) Township Sixteen (16)  
South Range Ten (10) E. W. M. thence westerly to the southwest corner of  
said Section Twelve (12); thence northerly to the township line on the  
north side of Township Sixteen (16) South Range Ten (10) E. W. M.; thence  
Westerly to the southwest corner of Section Thirty-two (32) Township Fifteen  
(15) South Range Ten (10) East; thence north to the point of beginning;

excepting however, from said district all and any land embraced within the boundary and limits of the town of Sisters in Crook County, Oregon, and lying within the proposed Squaw Creek Irrigation District, the land embraced within the said irrigation district lying within both Crook and Jefferson Counties, the major portion thereof lying within Crook County, Oregon.

And it further appearing that the Oregon and Western Colonization Company appeared at said hearing and requested that the following described timber lands not susceptible for irrigation be eliminated from said proposed district, to-wit: The north half of Section one, the East half of Section three, All of Section Five, the unplatted portion of Section Nine; the North half of Section Eleven; the West half and the West half of the Southeast quarter, the Southeast quarter of the South east quarter and the Southwest quarter of the Northeast quarter of Section Fifteen; All of Sections Seventeen, Twenty one, Twenty-three, twenty-seven, twenty-nine and thirty-five; the North half of the north half and the southeast quarter of the northeast quarter and the east half of the southeast quarter of Section Thirty three, all in township Fifteen South of Range Ten East of the Willamette Meridian. The North half of Section Twenty five and the West half of Section Thirty five in Township Fourteen South of Range ten East of the Willamette Meridian.

And it satisfactorily appearing to the Court that said described lands are not susceptible to irrigation in said district and the same should be excluded from said district.

It further appearing that J. H. Haner appeared and filed objections on behalf of Naven MacIntyre and requesting that the Southwest quarter of Section thirty two, township Fifteen South of Range Ten East of the Willamette Meridian be eliminated and excluded from said district on the ground that the same is not susceptible to irrigation and it appearing to the Court that said described lands are not susceptible to irrigation and should be eliminated and excluded from said district.

the proposed boundaries of the town of Clatsop in Clatsop County, Oregon, excepting however, the lands described by and with enclosed maps.

And it further appearing that George Brewster appeared for and on behalf of Hohn & Fried and request the elimination of Sections Sixteen, Township Fifteen South of Range Ten East of the Willamette Meridian be excluded from said district on the ground that the said described premises are not susceptible to irrigation and it appearing that said lands are not susceptible to irrigation and should be excluded from said district;

And the Shevlin-Hixon Company, a corporation appearing in person and by attorney and by filing a written objection inclusion of the following described lands, to-wit: the northwest quarter of section twenty eight, the north half of Section thirty four, in Township Fifteen South of Range Ten East of the Willamette Meridian, and it appearing to the court after considering said objections that said lands of said Shevlin Hixon Company will not be benefited by irrigation and should be excluded from said district;

And it further appearing to the court that the name of said proposed Irrigation District should be Squaw Creek Irrigation District, and that more than fifty of the owners of title to lands of said proposed district have signed said petition and request that the same be divided into five separate Divisions to be numbered First, Second, Third, Fourth and Fifty, and that one director should be elected from each of said Divisions;

It is therefore ordered, adjudged and decreed by the Court and the Court hereby declares that the requisite number of holders of title to the lands within the boundaries of said proposed irrigation district have petitioned for the formation and organization of said District and that the notice of the time of presentation of said petition and said petition has been duly published as required by law; That the name of said proposed Irrigation district shall be Squaw Creek Irrigation District, and it is hereby designated thereby; That said district shall be divided into five separate divisions to be numbered First, Second, Third, Fourth and Fifty and that one director shall be

electd from each of said divisions;

That the boundaries of the first addition shall be as follows:

Beginning at the southwest corner of section thirty two in township fifteen South of Range ten East of the Willamette Meridian thence north to the northwest corner of Section Five, Said township and range, thence East to the northeast corner of Section One, said township and range, thence south to the southeast corner of section twenty four; thence west to the southwest corner of section twenty four, thence south to the township line, thence west to the point of beginning.

That the boundaries of the Second Division shall be as

follows: Beginning at the southwest corner of Section eighteen, Township Fifteen South of Range Eleven East in Crook County, Oregon; thence North to the township line, thence West along the township line to Squaw Creek; thence down Squaw Creek to the interesection of the Section Line, the West side of Section Ten, Township Fourteen South of Range Eleven East, of the Willamette Meridian, in Crook County, Oregon, thence South about seven and three-quarters miles to the southeast quarter of Section Sixteen township Fifteen South Range Eleven East of the Willamette Meridian, thence West to the point of beginning.

That the boundaries of the Third Division shall be as follows:

Beginning at the southwest corner of Section thirty six township fifteen South of Range Ten East of the Willamette Meridian in Crook County, thence North to the southwest corner of section twenty four, thence East one mile to the township line; thence North to the southwest corner of Section Eighteen township fifteen South, Range eleven East of the Willamette Meridian, thence East to the Northeast corner of Section Twenty-one township fifteen south of range eleven East of the Willamette Meridian, thence south three miles to the township line, thence West to the north east corner of Section five, Township Sixteen South of Range 11 East of the Willamette Meridian, thence South to the Southeast corner of Section Seventeen, thence West to the southwest corner of Section eighteen, thence

north to the southwest corner of Section seven, thence West to the Southwest corner of Section Twelve, thence North to the township line thence west to the point of beginning.

That the boundary lines of the Fourth Division shall be as follows: Beginning at the southwest corner of Section three, township fifteen south of range eleven East of the Willamette Meridian, thence north along section line to Squaw Creek, thence down Squaw Creek crossing the southern boundary of Jefferson County and continuing down Squaw Creek to its intersection with the township line on the East side of Section Thirteen, Township Thirteen South of range eleven East of the Willamette Meridian thence South along the township line to the one-fourth corner on the East side of Section twenty four, thence east to the northeast corner of the northwest quarter of the northeast quarter of Section Twenty two, township fourteen South of Range Twelve East of the Willamette Meridian; thence South one half mile, thence West one fourth mile; thence South one-fourth mile, thence West one fourth mile; thence South one fourth mile, thence West one fourth mile to the one-fourth corner of the East Side of Section twenty eight, thence south one fourth mile, thence West one fourth mile, thence south one fourth mile, thence west to the north east corner of Section thirty two, thence South to the southwest corner of Section Five, thence West to the point of beginning.

That the boundaries of the Fifth Division shall be as follows: Beginning at the one-fourth corner of the West side of Section Nineteen, township fourteen south of Range twelve East of the Willamette Meridian, thence north along the township lines crossing the southern boundary of Jefferson County, and continuing along said township line to Squaw Creek, thence down Squaw Creek to the Deschutes river, thence southerly up the Deschutes River and crossing the northern boundary of Crook County and continuing up said Deschutes River to its intersection with the Southern boundary of Section fourteen township fourteen south of range twelve East, W. M; thence West to the southwest corner of Section

Fourteen, thence south to the one-fourth corner on the East side of Section Twenty two thence west to the point of beginning.

It is further ordered, adjudged and decreed that the boundaries of the said Squaw Creek Irrigation District be and they are hereby established and defined to be as follows: Beginning at the northwest corner of Section five in township fifteen south, range ten E. W. M. within Crook County, Oregon, running east to the intersection of Squaw Creek with the township line on the north side of township fifteen south of Range ten, East thence in a northeasterly direction down Squaw Creek and following the meanderings of said stream along the center of said stream to the boundary line between Jefferson and Crook Counties; thence following on down said stream within Jefferson County to its junction with the Deschutes river; thence in a southeasterly direction up the Deschutes River and following the meanderings of said river within Jefferson County to the line between Jefferson and Crook Counties; and thence following on up said Deschutes River to the intersection of said stream with the section line on the southside of Section Fourteen, township fourteen, south range Twelve East W. M. in Crook County, Oregon; thence westerly to the southeast corner of the southeast quarter of the northeast quarter of said Section; thence southerly to the southwest corner of the southeast quarter of the southeast quarter of said Section twenty two; thence westerly to the quarter corner on the south side of Section twenty-two; thence southerly to the southwest corner of the northwest quarter of the northeast quarter of Section twenty seven of said township and range; thence westerly to the southwest corner of the northeast quarter of the northwest quarter of said section; thence southerly to the southeast corner of the southeast quarter of the northwest quarter of said section twenty-seven, thence westerly to the quarter corner on the west side of said Section twenty seven; thence southerly to the southwest corner of the northwest quarter of the southwest quarter of said section; thence westerly to the southwest corner of the northeast quarter of the southeast quarter of section twenty eight, township fourteen south range twelve

E. W. M., thence southerly to the southwest corner of the southeast quarter of the southeast quarter of said section twenty eight, thence westerly to the southwest corner of section twenty eight, thence southerly to the southwest corner of section four, township fifteen south range twelve east W. M. thence westerly to the southwest corner of section three, township fifteen, South Range Eleven East; thence Southerly to the southwest corner of Section Thirty-four of said township and range; thence westerly to the northeast corner of Section five, township sixteen South Range Eleven E. W. M., thence southerly to the southeast corner of Section seventeen said township and range; thence westerly to the township line on the west side of said township; thence northly to the southeast corner of section twelve township sixteen south range Ten E. W. M. thence westerly to the southwest corner of said section twelve thence northerly to the township line on the north side of township sixteen south range ten E. W. M. thence westerly to the southwest corner of Section thirty-two township fifteen south range ten East; thence north to the point of beginning; excepting however, from said district, all and any land embraced within the boundary and limits of the town of Sisters, in Crook County Oregon, and lying within the proposed Squaw Creek Irrigation District, the land embraced within the said irrigation District lying within both Crook and Jefferson Counties, the major portion of which lies within Crook County, Oregon.

It is further ordered that all the land embraced within the boundary and limits of the town of Sisters in Crook County Oregon and lying within said Squaw Creek Irrigation District be excluded and eliminated therefrom, and that the following described lands belonging to the Oregon and Western Colonization Company be excluded from said District: North half of section one, the east half of Section three, all of Section Five, the unplatted portion of Section Nine, the north half of Section Eleven, the west half and the west half of the southeast quarter, the southeast quarter of the southeast quarter and the southwest quarter of

the northeast quarter of Section fifteen, Sections 17, 21, 23, 27, 29, and 35; the north half of the north half, the southeast quarter of the northeast quarter and the East half of the southeast quarter of Section thirty three, township fifteen south of range ten East of the Willamette Meridian; the north half of section 25, and the west half of Section 35, township 14 South of Range 10 East of the Willamette Meridian; and that the following described lands be and the same are hereby eliminated and excluded from said district: the northwest quarter of the Section 28 and the north half of Section thirty-four in township fifteen south of Range Ten East of the Willamette Meridian;

It is further ordered that the southwest quarter of Section 32, township 15 South of Range 10 East of the Willamette Meridian be eliminated and excluded from said district;

It is further ordered that Section Sixteen, township fifteen South, Range 10 East of the Willamette Meridian be and the same is hereby excluded from said district.
